2. RETURN OF DECEASED TO US IS ANTICIPATED NOVEMBER 23, 1972.

3. REPATRIATION OF SURVIVORS TO US HAS NOT YET BEEN DETERMINED PENDING POLICE DECISION.

4. STATUS OF INVESTIGATION IN GUYANA UNKNOWN AT THIS TIME OTHER THAN LARRY LAYTON, AGE ABOUT 25, CHARGED WITH MURDER IN THIS MATTER NOVEMBER 22, 1972.

5. TO DATE, THERE ARE 78 KNOWN SURVIVORS WHICH ARE THE SAME PERSONS BEING HELD BY GUYANAN AUTHORITIES.
