PORTATION. THEREFORE, THESE PERSONS WOULD NOT BE INTERVIEWED  
BY THE FBI TEAM AWAITING ARRIVAL OF SURVIVORS IN CHARLESTON,  
SOUTH CAROLINA. IT IS IMPERATIVE FBI BE ADVISED OF THE IDENTITY  
OF THOSE SURVIVORS LEAVING GUYANA BY COMMERCIAL AIRLINES, THEIR  
DESTINATION, AND ESTIMATED TIME OF ARRIVAL IN ORDER TO EFFECT  
AN INTERVIEW OF THESE PERSONS.
