1. WE HAVE BEEN THINKING OVER OUR REQUEST FOR THE TWO HELICOPTERS WHICH WE DESCRIBED AS QUOTE MILITARY ASSISTANCE TO GOC UNQUOTE. IT WOULD BE MORE ACCURATE TO CHARACTERIZE OUR REQUEST AS QUOTE CONTINUING MILITARY ASSISTANCE TO EMBASSY GEORGETOWN UNQUOTE.
2. IT IS THE EMBASSY'S PLAN TO CONTROL THE SCHEDULING OF THE HELICOPTERS IN ORDER TO UTILIZE THEM ALMOST EXCLUSIVELY FOR THE VARIOUS ASPECTS OF "PROTECTING" THE ASSETS LOCATED AT JONESTOWN, SUCH AS ASPECTS AS TRANSPORT OF LEGAL, SECURITY, INVESTIGATIVE AND CONSULAR PERSONNEL AND TRANSFER OF PROPERTY TO GEORGETOWN FOR SAFETYING, ETC.
3. SINCE THE PRIMARY FUNCTION TO BE SUPPORTED IS ESSENTIALLY CONSULAR AND SINCE SATISFACTORY ALTERNATIVE FUNDING ARRANGEMENTS SEEM NOT TO BE FEASIBLE, IT WOULD APPEAR LOGICAL TO LOOK TO THE EMERGENCIES IN THE DIPLOMATIC AND CONSULAR SERVICE APPROPRIATION TO RESOLVE THE PROBLEM.
