SUBJECT: GUYANESE AMBASSADOR MEETS WITH CONGRESSIONAL LEADERS RE. PEOPLES TEMPLE

1. GUYANESE EMBASSY, DCM, HALDER INFORMED DESK OFFICER TODAY (NOVEMBER 30) THAT GUYANESE AMBASSADOR MANN HAD CALLED ON THE SPEAKER OF THE HOUSE, O'NEILL, AND CHAIRMAN OF THE HOUSE INTERNATIONAL RELATIONS COMMITTEE, ZABLOCKI, ON NOVEMBER 29 TO EXPRESS CONDOLENCES FOR THE TRAGIC DEATH OF CONGRESSMAN RYAN ON BEHALF OF GOG AND TO EXPLAIN GOG'S POSITION REGARDING ITS CONTACTS WITH THE PEOPLES TEMPLE.

2. MANN TOLD O'NEILL AND ZABLOCKI THAT MANY VISITS WERE MADE TO JONESTOWN BY BOB LOE AND GEORGE-

TOWN BASED OFFICIALS OF VARIOUS MINISTRIES AND NO IRREGULARITIES WERE NOTED OR DID ANY JONESTOWN INHABITANTS EVER COMPLAIN ABOUT CONDITIONS. HALDER MENTIONED THAT MANN MADE THE POINT TO BOTH CONGRESSMEN THAT THE EMBASSY AND GOG CONSULTED INFORMALLY ON QUESTION OF MISTREATMENT OF TEMPLE MEMBERS BUT NO CORROBORATING INFORMATION WAS EVER DEVELOPED TO WARRANT AN OFFICIAL INVESTIGATION BY GOG NOR DID EMBASSY REQUEST GOG TO INVESTIGATE.

3. DESK OFFICER ESSENTIALLY AGREED WITH HALDER THAT MANN'S ASSERTION WAS CORRECT WITH ONE CAVEAT THAT THERE WERE INDIVIDUALS IN GOG WHO WERE SUSPICIOUS OF JONES BUT UNFORTUNATELY, LACKED ANY SUBSTANTIATING EVIDENCE TO SUPPORT ARGUMENTS THAT GOG CONDUCT OFFICIAL INQUIRY INTO TEMPLE ACTIVITIES.
