1. WE HAVE BEEN WORKING TO OBTAIN A PATHOLOGIST TO ASSIST  
GOG IN ITS INVESTIGATION AS REQUESTED. JUSTICE BELIEVES  
THAT ONE OF THE MILITARY PATHOLOGISTS WHO WERE  
INVOLVED IN THE INITIAL PHASES OF THE OPERATION WOULD  
BE MOST USEFUL TO GOG INVESTIGATION, AND GOG IS PREPARED TO  
NAME SUCH AN INDIVIDUAL AVAILABLE. JUSTICE IS WILLING TO  
MAKE APPROPRIATE FUNDING ARRANGEMENTS. PRINCIPAL DIEM-  
MILITARY IS AT SHORT SUPPLY OF PATHOLOGISTS  
DUE TO REQUIREMENTS AT DOVER, AND IS NOT  
ABLE TO ASSIGN A PATHOLOGIST TO GUYANA FOR AN EXTENDED

JUSTICE CURRENTLY REQUIRES INFORMATION REGARDING GOG  
NEEDS IN THIS CONNECTION. JUSTICE BELIEVES IT IS IN  
POSITION TO OBTAIN SERVICES OF PATHOLOGIST FOR A FEW DAYS  
FOR PURPOSES OF CONSULTATION WITH GOG AUTHORITIES.  
WE COULD ALSO OFFER TO RETURN HIM TO GUYANA TO TESTIFY  
DURING COURT PROCEEDINGS, IF NECESSARY. ALTERNATIVELY,  
CONSULTATION AND TESTIMONY COULD BE COMBINED INTO ONE  
VISIT AT A LATER DATE.

WE WOULD APPRECIATE YOUR PROMPT ADVICE ON THIS MATTER  
SO THAT WE CAN MOVE TO FINALIZE ARRANGEMENTS AND  
PROVIDE DEFINITIVE RESPONSE TO GOG REQUEST. NEWCOM
