1. PRELIMINARY INQUIRY INTO THE MURDERS OF CONGRESSMAN BYAM AND OTHER PERSONS RESUMED YESTERDAY (DEC 14).

2. TWO NEW WITNESSES WERE CALLED UPON TO TESTIFY. A POLICE PHOTOGRAPHER GAVE TESTIMONY AND SUBMITTED SIXTEEN EACH NEGATIVES AND PRINTS OF EXPOSURES HE TOOK AT 7:00PM VARIOUS LOCATIONS ON NOV 13. DALE PARKS WAS RECALLED TO EXAMINE THE PICTURES AND GIVE ADDITIONAL TESTIMONY. MONICA BRADY, THEN IN THE COURT ROOM FOR PERSONAL KNOWLEDGE FOR THE MURDER OF CONGRESSMAN AND WIFE KATHLEEN ON NOV 17 AND 18. SHE WAS RECALL TESTIMONY CROSS-EXAMINED BY SENIOR DEFENSE COUNSEL REY MONAY.

3. THE ATTORNEY GENERAL OF GEORGIA, J. MONAY AND SENIOR DEFENSE ATTORNEY WALTER WISSON INFORMED I AGREED TO ASSIST WITH THE LAYTON INQUIRY THROUGH DEC 30. MY VEHICLE MADE MY PRELIMINARY INQUIRY COULD BE COMPLETED. THEY AGREED TO POSITION OF THE INQUIRY REGARDING CARLS BRITISH.
