

FBI REPORT MADE BY TIM EIDEN.

I ARRIVED IN GEORGETOWN ON JANUARY 3, 1977 TO ASSIST IN A CHILD CUSTODY PROCEEDING IN THE SUPREME COURT BEFORE JUDGE BISHOP. MY WIFE, GRAISE STORN, ARRIVED WITH ME.

THE OPPOSING PARTY IN THE CUSTODY HEARING IS REVEREND JIM JONES OF PEOPLES TEMPLE AGRICULTURAL COMMUNITY. I WAS FORMERLY A MEMBER OF THE ORGANIZATION. JONES REFUSES TO RELEASE OUR SON TO US.

TODAY, JANUARY 18, 1977, AT 12:30 PM AT TINDENRI AIRPORT I WAS SUDDENLY SURROUNDED BY 3 PERSONS WHO TOLD ME TO BE MEMBERS OF PEOPLES TEMPLE. ONE IS A WHITE MALE AMERICAN TIMOTHY SWINNEY; SECOND IS A BLACK FEMALE AMERICAN JEROME FOURLETTE; AND THE THIRD IS UNKNOWN TO ME - HE IS A WHITE MALE AMERICAN WITH WIRE RIM GLASSES.

THIS CONFRONTATION TOOK PLACE IN THE IMMIGRATION AREA OF THE AIRPORT. JEROME FOURLETTE STARTED BY SAYING "WELL, WE'RE HERE TO SEE YOU OFF." I SAID "I WAS NOT LEAVING EVEN THOUGH YOU SAY SO." "THEY SUGGESTED I WOULD HAVE SAID THAT IF I WERE RESPONSIBLE FOR THE DESTRUCTION OF THE ORGANIZATION I WOULD HAVE TO GO." I SAID, "I WISH PEOPLES TEMPLE HAD JIM JONES NO HARM AND THAT HIS SON IS MY SON (HIS NAME IS GRAISE STORN, AGE 5). BOTH TIMOTHY SWINNEY AND JEROME FOURLETTE MADE FURTHER STATEMENTS TO THE EFFECT THAT THEY HAD INFORMATION OF AN IMPENDING ATTEMPT ON MY LIFE THEY WOULD STOP IT. I ASKED THEM TO STOP THE PROCEEDINGS. SWINNEY SAID I WOULDN'T STOP, TIM SWINNEY WENT STRAIGHT IN THE CAR AND SAID, "YOU HAVE EVERYTHING TO LOSE." I RESPONDED, "WHAT DO I HAVE TO LOSE?" SWINNEY RESPONDED, "YOUR LIFE." TIM SWINNEY REPEATED AGAIN THAT I HAD EVERYTHING TO LOSE ON FIGHTING THESE COURT PROCEEDINGS. I TOOK OUT MY CAMERA AND TOOK PICTURES OF THEM WHEN THEY HAD SAT DOWN WAITING APPARENTLY FOR ME TO LEAVE. THE PHYSICAL PRESENCE OF THE AFORESAID 3 PERSONS WAS WITNESSED BY MY TAXI DRIVER, HARRY MURRAY, WHO WORKS OUT OF THE HOTEL TOWER.
