Francisco, California. Said mailing shall occur no later than September 1,
1977. In the alternative Respondent STOEN may be personally served.

(6) Good cause appearing, the REV. JIM JONES is ordered joined
as a party to this action pursuant to Section 5159 of the California Civil
Code.

(7) Pursuant to Section 5154(l) of the California Civil Code,
