MCKAY OBJECTED THAT THE STATEMENT WASNOT FREE AND VOLUNTARY, BUT TOLD MAGISTRATE CHINTA THAT THE DEFENSE WOULD NOT APPLY FOR A VOIR DIRE HEARING ON THE ADMISSIBILITY OF THE STATEENT AS EVIDENCE UNLESS AND UNTIL LAYTON IS COMMITTED TO THE HIGH COURT FOR A TRIAL BY JURY.
