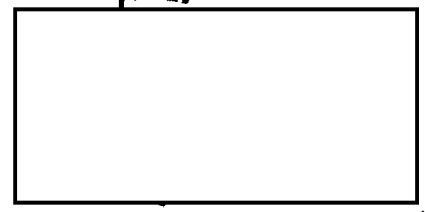

LATER ON DECEMBER 20, 1978, [REDACTED] SAID THAT SHE HAD DISCUSSED THE MATTER WITH ANDRUS AND MENDELSON AND ANDRUS HAS NEVER, TO HIS KNOWLEDGE, HAD ANY CONTACT WITH THE PT. MENDELSON RAN FOR THE CALIFORNIA STATE SENATE IN 1976. INITIALLY IT WAS HIS UNDERSTANDING THAT THE PT WAS SUPPORTING HIM, BUT HE LATER FOUND OUT THE PT WAS ACTUALLY SUPPORTING HIS OPPONENT. THE ONLY DIRECT CONTACT HE HAD WITH THE PT WAS IN THE SPRING OF 1976, WHEN HE APPEARED AT THE PT IN SAN FRANCISCO ALONG WITH THE SAN FRANCISCO CHIEF OF POLICE. MENDELSON IS CURRENTLY NOT IN WDC, AND HAS RETURNED TO SAN FRANCISCO FOR THE HOLIDAYS.
