ON DECEMBER 11, 1978, ONEIDA POLICE DEPARTMENT, ONEIDA,
NEW YORK, TELEPHONICALLY CONTACTED THE UTICA RESIDENT AGENCY AND
ADVISED THAT [REDACTED] ONEIDA, NEW YORK,

HAD CONTACTED THEIR AGENCY AND ADVISED HER SON, [REDACTED]
[REDACTED] HAD RECENTLY RETURNED FROM CALIFORNIA TO HER HOME. UPON
ARRIVAL, SHE REPORTED [REDACTED] INDICATED THAT HE HAD RETURNED

FROM THE UNITED STATES FROM GUIANA, WHERE HE HAD BEEN A MEMBER OF
THE PEOPLE'S TEMPLE, AND THAT HE WAS A PART CIPANT IN THE RECENT

MURDERS THERE. ACCORDING TO [REDACTED] HER SON HAD, ONLY A FEW
DAYS AGO, ADMITTED HIMSELF TO THE HUTCHINGS PSYCHIATRIC CENTER, IN
SYRACUSE, NEW YORK. *(u)*

ON DECEMBER 11, 1978, BUREAU AGENTS CONTACTED [REDACTED] AT HER RESIDENCE AND INTERVIEWED HER IN REFERENCE TO HER STATEMENTS TO THE ONEIDA POLICE. INTERVIEWING AGENTS STATED THAT DURING THE COURSE OF THE INTERVIEW, [REDACTED] DISPLAYED IRRATIC BEHAVIOR, AT TIMES WAS INCOHERENT AND DURING THE COURSE OF THE INTERVIEW, STATED THAT HER SON HAD NEVER TOLD HER THAT HE WAS IN GUIANA, BUT SHE ASSUMED THAT IN VIEW OF THE FACT THAT HE WAS IN SAN FRANCISCO, CALIFORNIA, WITH "A LOT OF CRAZY PEOPLE," HE VERY WELL COULD HAVE BEEN IN GUIANA. [REDACTED] STATED THAT HER SON IS A NARCOTICS ABUSER AND UPON RECEIVING HOME IN ONEIDA, NEW YORK, HE WAS, AT THE TIME ON NARCOTICS. INTERVIEWING AGENTS INDICATED THAT [REDACTED] APPEARED TO BE EMOTIONALLY UNSTABLE, AND SUBSEQUENT INTERVIEWS WITH OFFICIALS [REDACTED] IN SYRACUSE, NEW YORK, INDICATED THAT [REDACTED] HAS BEEN UNDER PSYCHIATRIC CARE FOR SOME TIME. HE ADMITTED TAKING DRUGS, USING ALCOHOL IN EXCESS AND ALSO SPOKE CONSIDERABLY ABOUT HIS HAVING "FOUND GOD." HE SPOKE AT SOME LENGTH ABOUT GOING TO [REDACTED]

SINCE THERE IS NO FURTHER EVIDENCE TO SUBSTANTIATE [REDACTED] [REDACTED]'S CLAIM THAT [REDACTED] WAS A PARTICIPANT IN THE MURDER OF CONGRESSMAN RYAN AND HIS PARTY IN GUIANA, OR THAT [REDACTED] WAS PRESENT IN GUIANA, ALBANY WILL NOT PROCEED ANY FURTHER IN AN ATTEMPT TO LOCATE [REDACTED] UNLESS REQUESTED BY SAN FRANCISCO.
