 WAS A HIGH FUNCTIONARY IN THE PT, ADVISED SENATOR BARRY
 GOLDWATER WAS ON THE PT'S ALLEGED HIT LIST. (u)

THREE POINTS NEED TO BE MADE CONCERNING THIS INFORMATION: (u)

1) IN AN FBI INTERVIEW OF BUFORD, THE SPECIFIC QUESTION WAS
 ASKED OF HER AS TO THE IDENTITIES OF PERSONS ON THE ALLEGED HIT
 LIST. SHE ADVISED THERE WAS NO WRITTEN HIT LIST BUT SEVERAL
 PERSON'S NAMES WERE GIVEN BY BUFORD. SENATOR GOLDWATER'S
 NAME WAS NOT GIVEN AT THAT TIME; 2) THE ALLEGED HIT LIST VARIED
