2. [REDACTED] FURTHER STATED THAT HE HAS BEEN IN TELEPHONE CONTACT WITH HIS SON [REDACTED] IN GEORGETOWN. [REDACTED] PURPORTEDLY HAD BEEN GIVEN PERMISSION BY GUYANESE AUTHORITIES TO TRAVEL TO TRINIDAD TO VISIT HIS FATHER BUT WAS REPORTEDLY STOPPED FROM BOARDING AN AIR FRANCE FLIGHT ON DECEMBER 26 BECAUSE HE ALLEGEDLY DID NOT HAVE A VISA FOR TRINIDAD AND TOBAGO. AS VISAS ARE NOT REQUIRED FOR U.S. CITIZENS TO ENTER TRINIDAD, [REDACTED] WOULD APPRECIATE ANY CLARIFICATION EMBASSY MIGHT BE ABLE TO PROVIDE AS TO WHETHER HIS SON HAS, IN FACT, BEEN GIVEN PERMISSION TO LEAVE GUYANA. [REDACTED] WAS REPORTEDLY GOING TO TRAVEL WITH PT MEMBER [REDACTED] WHO HAD ALSO BEEN RESIDING AT LAMAHA GARDENS. O'MAHONY
