

Regarding her escape from Jonestown, stated that her parents said they were going to the "Piggery," the place where animals were kept, and escaped through the bush. recalled hearing gunfire while in the bush. saw the following individuals in the bush: (N)
EDITH PARKS, DALE PARKS, TRACY PARKS (a little girl), JERRY PARKS, STANLEY KLEETON (PH), RICHARD CLARK, LESLIE WILSON, JAKARY WILSON (PH), ODELL RODES, JOHNNY FRANKLIN, ROBERT PAUL and DIANE LOUIE.
House-West was where EVETTE, EVA and STEPHANIE JONES resided. House-East was JIM JONES house. JONES lived alone and told people he was ill. thought JONES was Indian. JONES had a gun at meetings.
