(U) [REDACTED] THEORIZES THAT INITIAL BODY COUNT AT JONESTOWN WAS CORRECT. [REDACTED] ELITE GDF, HANDPICKED BY BIERNAN, FORCIBLY ROUNDED UP JONESTOWN SURVIVORS OF FIRST POISONING SESSION AND WAS RESPONSIBLE FOR THEIR MURDER TWELVE HOURS LATER. REASON FOR ABOVE, [REDACTED] WAS TO COVER UP RYAN KILLING AND PLACE TOTAL BLAME ON REVEREND JONES' CRAZED PLAN. [REDACTED] CLAIMED THAT BIERNAN WOULD NOT HAVE ALLOWED RYAN TO LEAVE GUYANA ALIVE, AND USED JONES AS WILLING DUPE. FOR THIS REASON BIERNAN DELAYED ALLOWING UNITED STATES OFFICIALS INTO JONESTOWN SO AUTOPSY COULD NOT BE PERFORMED DISCLOSING
