On 12/29/78, [redacted] who is employed as [redacted] Southern Railways, Erlanger, Kentucky and who resides at [redacted] Florence, Kentucky, telephone number [redacted] furnished the following information: (u)

On 9/7/78, [redacted] overheard a conversation on his ham radio between a female member of the Peoples Temple in Guyana, South America and an unidentified individual in either Indiana or Illinois. After that conversation was concluded, [redacted] immediately contacted the same female, who identified herself as TERRI TOUCHETTE, ham radio and station number WB6MID/8R3. They talked for approximately four minutes during which time TOUCHETTE indicated that she was a member of the Peoples Temple Agricultural/Medical Project in Guyana. The remainder of the conversation was basically "chit chat" and no mention was made of violence or anything of a subversive nature. (u)

[redacted] stated that TOUCHETTE subsequently sent him a picture postcard from GUYANA which depicted the Peoples Temple assisting the local inhabitants of that area in agricultural and medical endeavors. Though not specifically stated [redacted] interpreted the postcard as a means of soliciting donations. (u)
