ENCLOSURE

at the airfield boarded the smaller of two planes with LARRY LAYTON. MONICA BAGBY, and VERN GOSNEY (phonetic). boarded the larger plane. Before boarding the plane, members of Congressman RYAN's party insisted that LARRY LAYTON be searched for weapons. Congressman RYAN searched LAYTON, but did not find a weapon. However, LAYTON did not immediately board the plane and subsequent to speaking with JOE WILSON came on board. At that time, a tractor pulling a flat-bed trailer arrived at the airfield and observed the following individuals with weapons: [1.]

MARK LANE and CHARLES GEARY / U/				
stated that ODELL RHODES had told BRENDA PARKS that Rev. JONES had wanted "PONCHO" JOHNSON to kill MARK LANE and CHARLES GEARY at Jonestown. "PONCHO" took LANE and GEARY away, but then let them go because GEARY had done "PONCHO" a favor.
