

THE COMMITTEE HAS 8 REQUESTED FROM THE ATTORNEY GENERAL THE ASSISTANCE OF THE FBI IN CARRYING OUT ITS INQUIRY. THE COMMITTEE REQUEST INITIALLY INCLUDED ACCESS TO INVESTIGATIVE WORK PRODUCT OF THE FBI. IF AS A RESULT OF FBI INVESTIGATION THE IDENTITY OF ANY INDIVIDUAL IS DEVELOPED THAT MAY REASONABLY BE OF ASSISTANCE 18 TO THE COMMITTEE, THAT PERSON'S IDENTITY AND LOCATION MAY BE FURNISHED TO THE COMMITTEE IF IN YOUR VIEW TO DO SO WOULD NOT 16 JEOPARDIZE THE INTEGRITY OF THE INVESTIGATION AND IF THERE IS NO EXPECTATION OF CONFIDENTIALITY OR CONCERN OVER PERSONAL SAFETY ON THE PART OF THE INDIVIDUAL. IN THESE INSTANCES YOU SHOULD FULLY DISCUSS WITH THE INDIVIDUAL AT TIME OF INTERVIEW 12 HIS OR HER VIEWS ON FURNISHING INFORMATION TO THE COMMITTEE THE COMMITTEE MAY FURNISH YOU A LIST OF NEWS MEDIA 10 PERSONNEL AND REQUEST THAT THE LOCATIONS OF THESE INDIVIDUALS BE IDENTIFIED. 
