1. GOTT HAS REFUSED PT MEMBER [REDACTED] PERMIS-  
SION TO REMAIN IN TRINIDAD WITH THE VESSEL ALBATROSS III,  
AND HE IS BEING DEPORTED TO GUYANA THIS EVENING. KTA  
GEORGETOWN AT 2338 HOURS ON BWIA FLIGHT 487.

2. [REDACTED] INFORMED CONOFF JANUARY 18 THAT VESSEL WITH  
ITS GUYANESE CREW (INCLUDING PT MEMBER [REDACTED])  
WILL DISCHARGE ITS CARGO IN PORT OF SPAIN WITHIN 2-3 DAYS.  
VESSEL IS THEN EXPECTED TO RETURN TO GEORGETOWN FOR DRY-  
DOCK REPAIRS. ACCORDING TO [REDACTED] GEORGETOWN AGENT  
FOR THE ALBATROSS III (FERNANDES LIMITED) HAS RECEIVED  
ASSURANCE FROM GOG AUTHORITIES THAT NEITHER VESSEL NOR  
CREW WILL EXPERIENCE ANY DIFFICULTIES WHEN THEY RETURN  
TO GUYANA. [REDACTED] STATED THAT HE PLANS TO CONTINUE  
TO OPERATE THE ALBATROSS III BETWEEN GUYANA AND BARBADOS  
UNTIL CONTRARY INSTRUCTIONS ARE RECEIVED FROM PT LAWYERS  
IN SAN FRANCISCO AND PANAMA.
