2. 78 STATE 323801, WHICH IS ALL-INCLUSIVE COMPENDIUM, LISTS ONE SHIRLEY A. ROBINSON, DPOB 24 DEC 55; GEORGIA.

3. GUYANESE AUTHORITIES HAVE ISSUED TWO DEATH CERTIFICATES IN NAME OF SHIRLEY ANN ROBINSON. ONE SHOWS AGE TO HAVE BEEN 22, THE SECOND SHOWS AGE 35.

4. EMBASSY RECORDS INCLUDE XEROX PPT G1376856 ISSUED SHIRLEY ANN ROBINSON (DPOB 24 DEC 55; GEORGIA) ON 11 AUG 78 AT LOS ANGELES. WE ALSO HAVE A CALIFORNIA DRIVER'S LICENSE AND A GUYANESE IMMIGRATION CARD BOTH SAME NAME AND SAME DPOB AS US REF. GUYANA INTEROFFICE RECEIVED AN INQUIRY FROM
