THE FACT OF THE GUYANESE INSPECTION IN DETAIL OF ONE SHIPMENT WAS CONFIRMED BY THE CONTROLLER OF CUSTOMS TO THE AMBASSADOR AFTER NOVEMBER 18, 1978 BUT NO REASON (I.E., AN INTERPOL SUGGESTION) WAS STATED FOR THE INSPECTION. CONTROLLER VOLUNTEERED THAT THEIR SEARCH HAD BEEN NEGATIVE IN TERMS OF ANY CONTRABAND.
