2. PARA 5 OF REFTTEL INDICATES THAT EMBASSY HAS REJECTED BILL FOR STORAGE FEES PRESENTED BY ONE FREIGHT FORWARDER. BUREAU ENDORSES POST'S ACTION IN THIS INSTANCE AND URGES THAT POST CONTINUE TO ACT WITH EXTREME CAUTION IN RECEIV-

3. DEPARTMENT ASSUMES POST HAS CONSIDERED POSSIBILITY OF USING SPACE IN EMBASSY AND/OR AID WAREHOUSES, IF AVAILABLE FOR TEMPORARY STORAGE AND INVENTORY. ADVISE BEFORE MAKING COMMITMENT FOR RENTAL OF COMMERCIAL WAREHOUSE SPACE, POST SHOULD OBTAIN CLOSE ESTIMATE OF COST AND PERIOD OF RENTAL REQUIRED AND REQUEST APPROVAL FROM DEPARTMENT. ADVISE ARA/EX AND A/FBO.

4. HIRING OF MANUAL LABORERS IS AUTHORIZED. IF ADDITIONAL FUNDS ARE REQUIRED FOR THIS PURPOSE, POST SHOULD INDICATE IN NEXT ALLOTMENT ADJUSTMENT REQUEST TO ARA/EX/FM.

5. AUTHORIZATION TO HIRE PIT EMPLOYEES TO INVENTORY DECEDENTS' EFFECTS SHOULD BE REQUESTED FROM ARA/EX IN ACCORDANCE WITH INSTRUCTIONS CONTAINED IN ARA MANAGEMENT POLICY NO. 1 DATED 2/15/77. VANCE
