1. EIGHT MEMBERS OF THE PEOPLE'S TEMPLE HAVE FILED SUIT IN THE HIGH COURT AGAINST THE BOARD OF DIRECTORS OF THE PEOPLE'S TEMPLE DISCIPLES OF CHRIST IN GUYANA, THE PEOPLE'S TEMPLE CHRISTIAN CHURCH COMPANY, THE ATTORNEY GENERAL, THE GUYANA NATIONAL COOPERATIVE BANK, BARCLAY'S BANK INTERNATIONAL AND THE BANK OF GUYANA. THE PLAINTIFFS ARE: STEPHANS JONES, PAULA ADAMS, DEBORAH TOUCHETTE, MICHAEL TOUCHETTE, CHARLES TOUCHETTE, PHILIP BLAKEY, CHARLES BEIKMAN AND LARRY LAYTON. LAYTON IS CURRENTLY BEING TRIED FOR THE MURDER OF CONGRESSMAN RYAN AND OTHERS, WHILE BEIKMAN IS AWAITING TRIAL FOR THE MURDER OF SHARON AMOS AND HER THREE CHILDREN.

2. THE PLAINTIFFS CLAIM THAT AS CHURCH MEMBERS THEY WERE

ENTITLED TO SHARE IN ALL THE PROPERTY AND ASSETS HELD BY OR VESTED IN THE BOARD OF DIRECTORS OF THE PEOPLE'S TEMPLE CHRISTIAN CHURCH COMPANY, LTD., BY REASON OF AN EXPRESSED TRUST CONSTITUTED UNDER AND BY VIRTURE OF THE PEOPLE'S TEMPLE DISCIPLES OF CHRIST IN GUYANA.

3. THE PLAINTIFFS ALSO WANT THE COURT TO DECLARE THAT ADAMS, DEBORAH AND CHARLES TOUCHETTE ARE THE SURVIVING OR REMAINING MEMBERS OF THE BOARD OF DIRECTORS OF THE CHURCH IN GUYANA AND, AS SUCH, SHOULD BE DECLARED LEGALLY ENTITLED TO EXERCISE ALL THE POWERS CONFERRED ON THE BOARD AND TO TRANSACT BUSINESS ON ITS BEHALF.

4. THEY ARE ALSO SEEKING AN ORDER FOR LIQUIDATION OF THE PEOPLE'S TEMPLE CHRISTIAN CHURCH COMPANY, LTD. UNDER THE SUPERVISION OF THE COURT. FURTHER, THEY ARE ASKING THE COURT TO DECLARE THAT THE BOARD OF DIRECTORS OF THE CHURCH AND/OR THE COMPANY ARE LEGALLY BOUND UNDER THE EXPRESSED OR IMPLIED TERMS OF AN AGREEMENT WITH THE CHURCH TO PROVIDE THE PLAINTIFFS
