1. SINCE DELIVERING CHAIRMAN ZABLOCKI'S LETTER TO PRIMIN  
BURNHAM REQUESTING THAT BFAC STAFF MEMBERS BE PERMITTED TO  
INTERVIEW GUYANESE GOVERNMENT OFFICIALS (REFERTEL A),  
AMBASSADOR HAS ASKED FORMIN ON THREE SEPARATE OCCASIONS  
WHEN A REPLY MIGHT BE FORTHCOMING. THE DELAY, HE STATES,  
WAS PRINCIPALLY BEEN DUE TO THE PRESS OF THE OTHER URGENT  
BUSINESS SUCH AS FINAL CABINET CONSIDERATION OF THE BUDGET  
(WHICH IS TO BE PRESENTED IN PARLIAMENT TODAY, MARCH 12),  
AS WELL AS CABINET'S PREOCCUPATION WITH THE SEVERAL SERIOUS  
LABOR DISTURBANCES WHICH HAVE PLAGUED GUYANA FOR THE LAST  
FORTNIGHT.
