1. (LOU) HFAC STAFF HAVE RAISED QUESTION REGARDING THEIR SECURITY WHILE THEY ARE IN GUYANA. DEPARTMENT WOULD APPRECIATE ANY COMMENTS OR SUGGESTIONS EMBASSY MAY HAVE. SUBJECT WAS RAISED BY STAFF MEMBER IN VIEW OF RECENT SUICIDE OF TEMPLE MEMBER MICHAEL PROKES IN BELIEF REMAINING TEMPLE MEMBERS IN GUYANA MAY HARBOR ILL WILL TOWARDS STAFF WHOSE VISIT IS IN CONNECTION WITE DEATH OF CONGRESSMAN RYAN WHO WAS CAUSE OF DEMISE OF TEMPLE.
