1. HOTEL RESERVATIONS MADE FOR STAFFDEL AND MS BAUMANN OF
L AT TOWER HOTEL. FULL STAFFDEL CANNOT BE ACCOMMODATED AT
PEGASUS HOTEL DUE TO WEST INDIES CRICKET MATCHES BEING HELD
BUYAMA. TOWER ALSO LIKELY TO PROVE MORE COMFORTABLE IF MORE
SIMPLE AS AIR CONDITIONING IN PEGASUS HAS FAILED AND UNLIKELY
TO BE REPAIRED BY ETA STAFFDEL. FINALLY, TOWER IS LITTLE MORE
THAN BLOCK FROM CHANCERY AND FROM AID BUILDING WHERE WE HAVE
ARRANGED FOR STAFFDEL OFFICE SPACE.

2. CONTROL OFFICER FRANKLIN ENGLISH WILL MEET AND ASSIST
THROUGH CUSTOMS.

3. AIRCRAFT HAS ALREADY BEEN RESERVED FOR THURSDAY, MARCH 22
FOR TRIP TO PORT KAITUMA. THIS HAD BEEN LAID ON SEVERAL DAYS
PRIOR TO RECEIPT REFTEL (PARA 3). WRITTEN REQUEST TO GOG FOR
PERMISSION TO VISIT JONESTOWN WAS ALSO SUBMITTED MARCH 12
SPECIFYING MARCH 22. UNLESS THERE ARE OVERRIDING CONSIDERATIONS
OF WHICH EMBASSY UNAWARE BELIEVE THEREFORE WE SHOULD HOLD ON
THAT DATE RATHER THAN ATTEMPT TO RESCHEDULE NOW FOR MARCH 19.
