1. CRIMMINS/CARPENTER REPORT HAS NOW BEEN RECEIVED AND I  
HAVE HAD AN OPPORTUNITY TO REVIEW ITS CONTENTS. I HAVE  
WRITTEN A LETTER TO AMBASSADOR CRIMMINS WITH MY INITIAL  
IMPRESSIONS, A COURTESY COPY OF WHICH HAS ALSO BEEN SENT TO  
YOU. I EXPECT TO HAVE FURTHER COMMENTS ON THE REPORT.

2. IN THE MEANTIME, HOWEVER, I HAVE DISCOVERED WITH FRANK  
AMAZEMENT THAT THE REPORT DOES NOT CONTAIN THE FULL TEXT  
OF MY JUNE 6 CABLE. WHAT APPEARS IN THE REPORT IS AN EX-  
TENSIVELY EDITED VERSION OF THAT CABLE WHICH OMITTS SEVERAL  
SENTENCES AND OMISSIONS OTHER PORTIONS. BECAUSE THE JUNE CABLE  
EXCHANGE HAS SUCH IMPORTANCE AND BECAUSE CRIMMINS AND  
CARPENTER LAID SUCH HEAVY STRESS ON THE PRECISE LANGUAGE  
USED, I FIND IT INCOMPREHENSIBLE THAT THE VERBATIM TEXT  
WAS NOT REPRODUCED. I BELIEVE, THEREFORE, THAT IT IS  
QUITE IMPORTANT THAT PUBLIC AFFAIRS MAKE AVAILABLE THE
