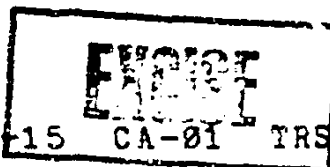

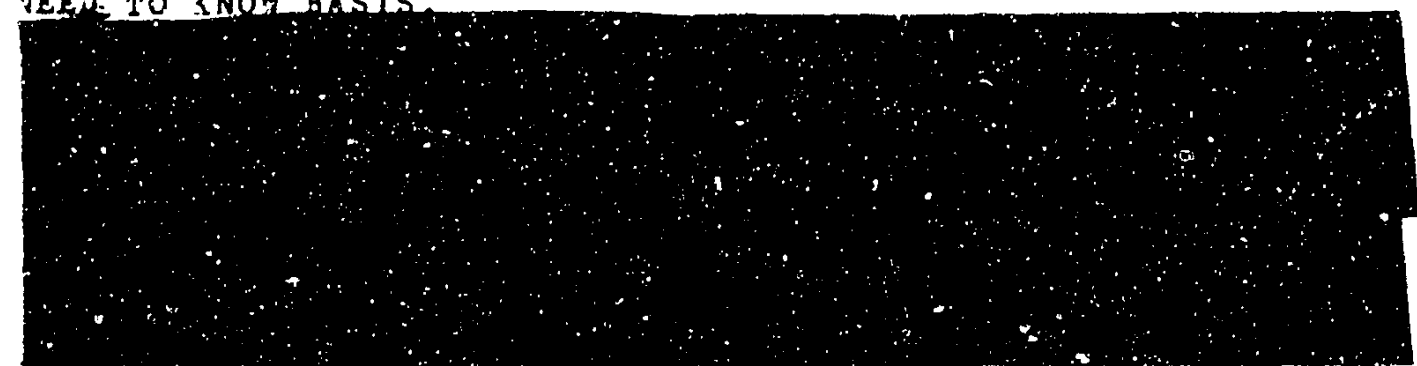

1. THOSE CHECKS BELONGING TO KNOWN SURVIVORS OF THE JONESTOWN DISASTER SHOULD BE RETURNED TO THE SURVIVORS AS QUICKLY AS POSSIBLE BY REGISTERED MAIL. SINCE GEORGETOWN MAY NOT HAVE THE MOST RECENT ADDRESS OF EACH INDIVIDUAL SURVIVOR, THEY ARE PROVIDED BELOW. THIS INFORMATION IS COVERED BY THE PRIVACY ACT AND MAY NOT BE RELEASED EXCEPT TO OTHER U.S. GOVERNMENT AGENCIES ON A NEED TO KNOW BASIS.
