1. I AM MOST GRATEFUL THAT THE FULL TEXT OF MY JUNE 6 CABLE (GEORGETOWN 1815) AND THE DEPARTMENT'S REPLY (STATE 131993) WILL BE PUBLICLY RELEASED. I WOULD APPRECIATE BEING INFORMED AS TO THE DATE THIS WILL BE DONE.
2. REGARDING THE LAST SENTENCE IN PARA 1 OF YOUR REPLY, CERTAINLY I DID NOT EXPECT THE DEPARTMENT TO MAKE THE NECESSARY CORRECTIONS IN THE CRIMMINS/CARPENTER REPORT. I REALIZE THAT THEIR REPORT WAS AN INDEPENDENT STUDY COMMISSIONED BY YOUR OFFICE AND THAT ANY CORRECTION SHOULD COME FROM THE AUTHORS THEMSELVES. THAT IS WHY I ADDRESSED MY MAY 7 LETTER DIRECTLY TO AMBASSADOR CRIMMINS WITH A COPY TO MR. STANLEY CARPENTER. I EXPECT THEM TO ISSUE THE CORRECTION TO THEIR CONCLUSION SO THAT IT ACCORDS WITH THE FACTS ON THE RECORD, AS REQUESTED IN MY LETTER. I ATTACH GREAT IMPORTANCE TO THEIR DOING THIS WITHOUT FURTHER DELAY.
