MEMBERS HELD AT GUYANA STATE WAREHOUSE AND AT GUYANA AIRWAYS
CORPORATION STORAGE SITE.

TO CONOFF) WERE PERSONAL PAPERS OF DONNA STANFIELD. CONOFF IS
IN COMMUNICATION WITH MRS. STANFIELD'S NEXT OF KIN AND REPRESENTATIVE
REGARDING SHIPMENT OF HER PERSONAL PAPERS AND HER HUSBAND'S
DOCUMENTS.
