2. DCM HAS HAD AN OPPORTUNITY TO BORROW BRIEFLY A SOON TO BE RELEASED BOOK BY AMERICAN ATTORNEY MARK LANE ON THE SUBJECT OF THE PEOPLES TEMPLE. IT IS ENTITLED "THE STRANGE POISON" AND IS PUBLISHED BY HAWTHORN BOOKS, A DIVISION OF ELSEVIER-DUTTON, NEW YORK, COPYRIGHT 1980.

3. "THE STRANGE POISON" IS HIGHLY CRITICAL OF THE DEPARTMENT'S AND EMBASSY'S HANDLING OF THE PEOPLES TEMPLE TRAGEDY. IT ATTRIBUTES, FOR EXAMPLE, THE DEATH OF CONGRESSMAN LEO RYAN TO THE DELIBERATE WITHHOLDING OF INFORMATION BY THE DEPARTMENT AND THE EMBASSY. MOST AMERICAN NEWS MEDIA ARE DIRECTLY OR IMPLICITLY SUGGESTED TO HAVE BEEN CO-CONSPIRATORS WITH
