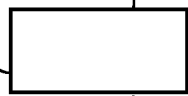

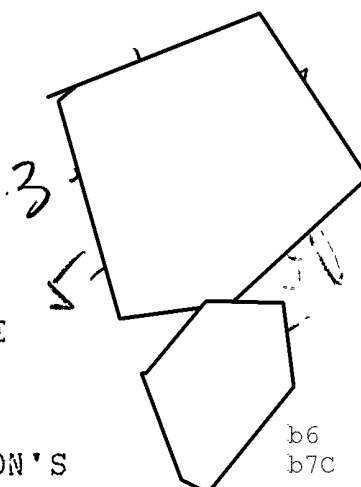

In view of FBIHQ's decision not to augment SF's complement for the RYMUR special, SF advised of its intention to utilize three agents currently assigned FCI matters to full time duties on the special until its completion, which has been estimated to be a minimum of eight weeks. SF's mandated FCI complement was set at 78. During the last two TURK periods it has been devoting the equivalent of 85 and 79.5 agents to the FCI program. 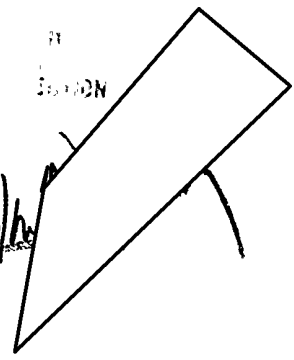
