On 11/24/78, Deputy Assistant Director CONRAD BANNER advised that he had been requested through Bureau headquarters to provide the government of Guyana with fingerprint equipment. As a result, the Dover, Delaware Resident Agency sent to the government of Guyana one fingerprint camera, US identification number 75468. Subsequent to sending this camera to Guyana, it was felt that return of the camera by the Guyanese was highly improbable. As a result, appropriate documentation was forwarded to the Bureau to remove the camera from Automated Inventory System. (u)

On 6/6/79, camera was received by the Brooklyn Queens Resident Agency along with other items forwarded to the Guyanese government. The camera was in turn forwarded to the Baltimore Division and reissued to the Dover Resident Agency. (u) (PC)
