2. THE EMBASSY IN GEORGETOWN DOES NOT REPORT NOT HAVE ACCOMMODATION EXCHANGE FACILITIES AND DOES NOT REPORT NOT HAVE U.S. DOLLARS ON HAND. ALSO, IT IS ILLEGAL FOR A GUYANESE NATIONAL TO TAKE MORE THAN GUYANA DOLLARS 200 (TWO HUNDRED) IN FOREIGN EXCHANGE OUT OF THE COUNTRY. GUYANA DOLLARS 200 IS THE EQUIVALENT OF U.S. DOLLARS 78.58, (SEVENTY EIGHT DOLLARS AND FIFTY EIGHT CENTS).

3. AS THE GOG ALLOWS GUYANA DOLLARS 200 OUT OF THE COUNTRY IN FOREIGN EXCHANGE WITHOUT COMPLICATED BANK TRANSACTIONS, THE EMBASSY WOULD LIKE TO SUGGEST THE

FOLLOWING PROCEDURE FOR PROVIDING SOME U.S. DOLLAR TO THE WITNESSES. BOTH JUSTICE AND THE DEFENSE ATTORNEYS HAVE AUTHORIZED THE EMBASSY TO PROVIDE EACH OF THEIR WITNESSES U.S. DOLLARS 78.58. THIS SUM WILL BE GIVEN TO EACH WITNESS, BY THE EMBASSY, IN GUYANA DOLLARS. IT WILL THEN BE UP TO EACH INDIVIDUAL TO EXCHANGE THIS MONEY FOR U.S. DOLLARS. WHILE THIS IS A CUMBERSOME ARRANGEMENT, IT APPEARS TO BE THE ONLY WAY THE EMBASSY CAN PROVIDE A MINIMUM OF U.S. DOLLARS FOR USE ON ARRIVAL AT POE. THIS MINIMUM AMOUNT WILL ALLOW FOR UNEXPECTED EXPENSES SUCH AS NOT BEING MET AT THE AIRPORT OR THE PLANE'S BEING DIVERTED TO ANOTHER POE.

4. THE EMBASSY HAS DISCUSSED WITH THE DEFENSE ATTORNEYS THE PROCEDURES DESCRIBED IN PARAGRAPH 3. THEY HAD NO OBJECTIONS TO THIS ARRANGEMENT.

5. THE EMBASSY NEEDS TO KNOW THE FOLLOWING:

A) DOES JUSTICE AGREE WITH THE SUGGESTION OUTLINED IN PARAGRAPH THREE ABOVE?

B) WHAT ARRANGEMENTS ARE BEING MADE FOR THE DEFENSE ATTORNEYS TO TRANSMIT AUTHORIZATION OF FUNDS FOR THEIR WITNESSES?

C) EMBASSY WILL REQUIRE THE NAMES AND PHONE NUMBERS OF OFFICIALS IN THE U.S., BOTH FOR JUSTICE AND DEFENSE WITNESSES. THESE NAMES WILL BE GIVEN TO THE WITNESSES IN THE EVENT THEY SHOULD NOT BE MET AT POE.

D) SHOULD BOTH JUSTICE AND THE DEFENSE SUBPOENA THE SAME WITNESSES, WHICH AUTHORIZATION FOR FUNDS AND PER DIEM SHOULD BE USED?

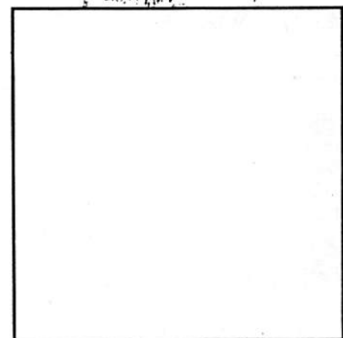

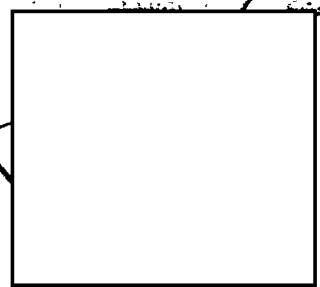
