[] ADVISED THAT DURING THIS APPEAL, HE MADE PHONE PATCH TO (415) 922-9597. THE ENDO-CRINOLOGIST, WHO WAS CONTACTED SPOKE TO PT ON SEVERAL OCCASIONS AND IS BELIEVED TO HAVE SPOKEN TO DR. SCHACT ON AT LEAST ONE OF THESE CONNECTIONS. THE ENDO-CRINOLOGIST RESIDES IN THE NY APEA AND HAS EXPRESSED DESIRE TO

[] NOT TO BE CONTACTED IN THIS INVESTIGATION. (u)

IN CONNECTION WITH THE MEDICAL CONTACT, [] RECEIVED A LETTER, DATED OCTOBER 20, 1977 ON STATIONARY MARKED, "THE WHITE HOUSE" SIGNED BY LANDON KITE, STAFF ASSISTANT, IN WHICH KITE ADVISED THAT PRESIDENT CARTER HAD BEEN CONTACTED BY TOM ADAMS AND THAT PRESIDENT CARTER WAS PLEASED ABOUT THE ASSISTANCE [] HAD PROVIDED TO THE PT. [] STATED IT WAS HIS BELIEF THAT DUE TO THIS LETTER AND THE FACT THAT THE PT OPERATED A RADIO IN JUNGLE AREA, THAT THEY HAD BEEN SANCTIONED BY THE UNITED STATES GOVERNMENT. (u)

[] FURTHER ADVISED THAT WB6MID/8R3 WAS ON RADIO QUITE OFTEN AND AS OF EARLY NOVEMBER, 1978, PRIOR TO ASSASSINATION, HE NO LONGER HEARD THEM ON THE BAND. [] STATED THAT AT THIS TIME, HE ATTEMPTED TO CALL PT ON RADIO BUT ALL CALLS MET WITH NEGATIVE RESULTS. (u)

[] PROVIDED THE NAME CHARLES C. BENSON CALL 8R1CB, DEMERAYA, GUYANA AS POSSIBLY POSSESSING KNOWLEDGE OF PT RADIO OPERATION. (u)

REFERENCED BROOKLYN-QUEENS TELETYPE STATES THAT PT HAS MADE MORE THAN 2,000 RADIO CONTACTS IN THE UNITED STATES AND THAT LIST OF THESE RADIO CONTACTS PROVIDED TO THE WHITE HOUSE AND MANY UNITED STATES CONGRESSIONAL REPRESENTATIVES. KITE'S LETTER TO [] SUPPORTS CONTENTION THAT PT CONTACTED WHITE HOUSE WITH LIST. (u)
