SAN FRANCISCO IS NOT AWARE OF HOW REMAINING UNIDENTIFIED BODIES ARE CLASSIFIED AT DOVER AIR FORCE BASE, OR IF IT WOULD BE FEASIBLE TO X-RAY KNEES OF REMAINS OF ALL NMJ'S MATCHING DENNIS' DESCRIPTION IN ORDER TO EFFECT A COMPARISON. ALSO, IT IS NOT KNOWN WHETHER THE DENTAL WORK DESCRIBED IN RETEL CAN BE OF AID IN IDENTIFICATION. (u)
