UPON REINTERVIEW WITH JULIUS EVANS, HE ADVISED THAT HE WAS
A RESPIRATORY THERAPIST WHILE AT THE PT COMMUNE IN JONESTOWN.
ON NOVEMBER 18, 1978, HE AND HIS FAMILY IN THE EARLY MORNING
HOURS DEPARTED THE COMMUNE, OSTENSIBLY TO GO ON A PICNIC, BUT
ACTUALLY TO ESCAPE. THEY MADE THEIR SAFE ESCAPE THROUGH THE
JUNGLES. EVANS STATED THAT ~~HE HAD~~ NOTHING TO DO WITH THE
MIXING NOR DID HE HAVE ANY KNOWLEDGE OF THE SUICIDE ~~POTION~~.
DURING THE NIGHT PRIOR TO THE ASSASSINATION OF CONGRESSMAN
RYAN, EVANS ADVISED THAT HE CONFINED HIMSELF TO HIS LIVING
