1. FOUR WITNESSES TESTIFIED FOR THE PROSECUTION DURING THE
FEB. 1 SESSION OF THE PRELIMINARY INQUIRY INTO THE DEATHS OF
LINDA SHARON HARRIS (AKA SHARON AMOS) ET AL. DR. CYRIL LESLIE
MOOTOO, WHO PERFORMED AUTOPSIES ON THE DECEASED, GAVE THE
FINDINGS OF THE EXTERNAL EXAMINATIONS. CROSS-EXAMINATION WAS
DEFERRED BY THE DEFENSE UNTIL FEB. 2. A POLICE CONSTABLE WHO
ACCOMPANIED STEPHANIE JONES TO THE HOSPITAL ON NOV. 19
TESTIFIED. STEPHANIE JONES GAVE UNSWORN TESTIMONY CONCERNING
HER EXPERIENCE ON THE NIGHT OF THE MURDERS. BECAUSE HER
TESTIMONY IN THE EXAMINATION CONFLICTED WITH SIGNED STATEMENTS
