BY TELETYPE DATED FEBRUARY 8, 1979, TO THE BUREAU SAN FRANCISCO ADVISED THAT INFORMATION DEVELOPED FROM NEWS SOURCES THAT STEPHEN GANDHI JONES, BORN JUNE 1, 1959, HAS FINISHED TESTIMONY AND HAS BEEN GIVEN PERMISSION BY GOG TO LEAVE GUYANA.

LEGAT AT GEORGETOWN IS REQUESTED TO ASCERTAIN STATUS OF JONES AS WELL AS ANY FUTURE TRAVEL PLANS. ALERT STATE DEPARTMENT AS WELL AS AIRLINES THAT FBI AND ASSISTANT U. S. ATTORNEY, SAN FRANCISCO, IS DESIROUS OF IMMEDIATE NOTIFICATION OF ANTICIPATED TRAVEL PLANS BY JONES, AS WELL AS ANY OTHER PEOPLE'S TEMPLE MEMBERS REMAINING IN GUYANA. (u)
