I could estimate that were living at the said settlement. I never went back to Jonestown. During the time I was at Jonestown; I went with A.C.O. Roberts to the chicken farm and there I pointed out the chicken feed bag in which I had left money. I also pointed out the suit case. I also took A.C.C. Roberts to the bahana fields where money was buried. I could not at that time find where money was buried but later with the assistance of Mike Prokes and my brother Timothy Carter money was recovered. Police took possession of all these things: The guns that were given to us by Maria Katsarsis had ammunition mine had five rounds and I later removed those and put them in my pocket. I saw Security Guards at Jonestown. Persons were not permitted to leave Jonestown if they wanted.

Cross-examined:- None.

Q. by members of the Jury:-

I did see dead body of Ann Elizabeth Moore lying on the floor and she appeared to have been shotp this was when I saw body of Maria Katsarsis. There was no power failure when Maria Katsarsis spoke to me.

Q. by Coroner:-

Ann Elizabeth Moore had a sister at Jonestown whose name was Carolyn Layton.
