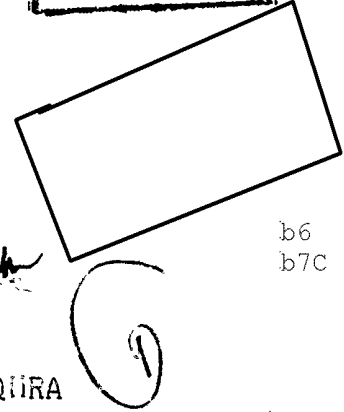

WITH REGARD TO REFERENCED BALTIMORE TELETYPE, ARRANGEMENTS WERE MADE WITH [REDACTED] SEROLOGY UNIT, LABORATORY DIVISION, TO DIRECTLY CONTACT COLONEL WILEY E. COWAN, ARMED FORCES INSTITUTE OF PATHOLOGY, WALTER REED ARMY MEDICAL CENTER, AND COORDINATE WITH COLONEL COWAN EXACTLY WHAT MATERIAL WAS NEEDED BY THE LABORATORY AND WHAT WAS AVAILABLE THROUGH THE ARMED FORCES INSTITUTE OF PATHOLOGY. [REDACTED] ADVISED JANUARY 8, 1979, THESE ARRANGEMENTS HAD BEEN ACCOMPLISHED.

REFERENCED BROOKLYN/QUEENS MRA TELETYPE STATED THAT HAM RADIO OPERATORS WITH CALL LETTERS [REDACTED] AND [REDACTED] (A RETIRED AIR FORCE COLONEL) HAD NUMEROUS CONTACTS WITH THE PEOPLES TEMPLE (PT) HAM RADIOS IN GUYANA. THIS TELETYPE ALSO INDICATED THAT PT MEMBERS WERE ALLEGEDLY INVOLVED IN ILLEGAL NARCOTICS TRAFFIC BETWEEN GUYANA AND MIAMI AND FLORIDA RADIO OPERATORS MAY BE INVOLVED OR HAVE KNOWLEDGE OF THIS ACTIVITY (u)
