AUSA, SAN FRANCISCO, ADVISED LEGAL STATUS OF LAYTON IS OF PARAMOUNT INTEREST TO HIS OFFICE AND THE FGJ, SAN FRANCISCO AND THAT EVERY EFFORT SHOULD BE MADE TO INSURE PROMPT NOTIFICATION TO FBI, SAN FRANCISCO OF CURRENT AND FUTURE STATUS AND INTENTIONS OF PROSECUTION BY GOG. (u)

LEGAT AT U.S. EMBASSY GEORGETOWN IS REQUESTED TO OBTAIN CURRENT STATUS OF LAYTON AND INTENTIONS OF PROSECUTION BY GOG AND EXPEDITE SAME TO SAN FRANCISCO (u)
