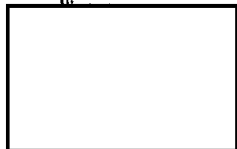

ON MARCH 14, 1979, LIEUTENANT [redacted]

VOICE IDENTIFICATION UNIT, MICHIGAN STATE POLICE, EAST

LANSING, MICHIGAN, TELEPHONICALLY ADVISED THAT THE

"NATIONAL INQUIRER" REQUESTED HIM TO COMPARE A TAPE RECORDING

CONTAINING STATEMENTS REPORTEDLY MADE BY JIM JONES

IMMEDIATELY BEFORE THE MASS SUICIDE IN NOVEMBER 1978,

IN JONESTOWN, GUYANA, WITH A KNOWN SAMPLE OF JONES' VOICE

IN ORDER TO DETERMINE IF THE "NATIONAL INQUIRER" TAPE WAS

AUTHENTIC. LIEUTENANT [redacted] ADDED THAT THE INFORMATION

CONTAINED ON THIS TAPE WAS APPARENTLY USED ON THE "TODAY" MAR 20 1979
