FBIHQ HAS AUTHORIZED TRAVEL OF SA DONALD R. HALE, SAN FRANCISCO CASE AGENT IN CAPTIONED MATTER, TO GUYANA FOR THE PURPOSE OF MEETING WITH APPROPRIATE OFFICIALS OF THE GOVERNMENT OF GUYANA IN AN EFFORT TO SECURE PRECISE INFORMATION TO BRING THIS INVESTIGATION TO A LOGICAL CONCLUSION.
