GUYANESE GOVERNMENT DENIED BOTH REQUESTS AND COMMITTEE STAFF MEMBERS WERE LIMITED TO INTERROGATION OF US EMBASSY STAFF MEMBERS ONLY DURING THEIR VISIT TO GUYANA.
