NOTE: TRAVEL OF SA HALE, SAN FRANCISCO TO GUYANA, ALONG WITH LEGAT OGLESBY HAS BEEN PREVIOUSLY APPROVED. STATE DEPARTMENT, HOWEVER, HAS ADVISED OF BUREAUCRATIC ENTANGLEMENTS INVOLVING PREVIOUS DENIAL OF THE GOVERNMENT OF GUYANA TO RECEIVE OFFICIAL REPRESENTATIVES OF THE U. S. CONGRESS WHO ARE INVESTIGATING THIS MATTER. SKIP ROBERTS, ASSISTANT COMMISSIONER OF POLICE, GUYANA, HAS BEEN THE GUEST OF THE FBI IN THE UNITED STATES, AND DIRECT CONTACT IS BEING MADE WITH HIM AS A LOGICAL CONTINUATION OF OUR LIAISON WITH HIM.
