DOCTORS APPARENTLY HEARD MAKING THE COMMENT THAT THERE WERE

IT HAS BEEN DETERMINED THAT ALL THE DRUGS AND NARCOTICS AND
4 MEDICAL SUPPLIES AT JONESTOWN APPARENTLY NOT ITEMIZED WERE
IMMEDIATELY TRANSPORTED TO HOSPITALS IN JONESTOWN AND
