BY TELETYPE DATED MAY 8, 1979, TO THE BUREAU SAN FRANCISCO ADVISED THAT INVESTIGATION AT GEORGETOWN, GUYANA, DETERMINED THAT ORIGINAL "LAST HOUR" TAPE CURRENTLY IN POSSESSION OF U. S. AMBASSADOR, AMERICAN EMBASSY, GEORGETOWN, GUYANA. THROUGH TELEPHONIC CONVERSATIONS, FBI LAB, RADIO ENGINEERING SECTION, IT IS BELIEVED THAT FBI LAB COULD AMPLIFY AND CLARIFY AND CLEAN "LAST HOUR" TAPE IF THEY WERE IN POSSESSION OF ORIGINAL (u) USA, SAN FRANCISCO ADVISED "LAST HOUR" TAPE IS PRIMARY EVIDENCE IN ANTICIPATED PROSECUTION, SAN FRANCISCO DIVISION AND POSSESSION OF ORIGINAL BY FBI IS PROPER. (u) THE U. S. DEPARTMENT OF STATE IS REQUESTED TO OBTAIN ORIGINAL FROM AMBASSADOR, U. S. EMBASSY, GEORGETOWN, INSURE
