ON MAY 10, 1979, LT. COLONEL BRUCE POITRAST, CHIEF,  
HOWARD AIR FORCE BASE CLINIC, CANAL ZONE, ADVISED THAT HE WAS  
PROBABLY THE FIRST DOCTOR ON THE SCENE AT JONESTOWN, GUYANA,  
ALONG WITH PATHOLOGIST LEN CROOK, UNIVERSITY OF SOUTH CAROLINA  
MEDICAL SCHOOL, CHARLESTON, SOUTH CAROLINA. POITRAST STATED  
THAT HE NOTED THAT JONESTOWN HAD A VERY WELL STOCKED PHARMACY  
THAT COULD EASILY HAVE LASTED FOR A PERIOD OF TWO YEARS FOR  
THAT POPULATION GIVEN AT THAT TIME. HE STATED THAT HE NOTED
