For reasons of brevity, this report will deal only with audio magnetic tapes Q127 through Q143 and Q568 through Q815. Additional audio tapes will be described in subsequent reports. (u)

For information of San Francisco, many of the cassette tapes had extensive writing on them and/or had 3X5 cards attached describing what the tape was supposed to contain. However, nearly all of the cassette tapes Q568 through Q815 were copied on high-speed duplicating equipment which precludes any monitoring during the duplicating process. Therefore, it is not known whether the cards or other writing accurately describe what the tapes contain. It is possible that many of the copied tapes are blank on one or both sides. (u)
